would need to be set back from the carriageway edge as far as possible to provide for the best possible visibility for all oncoming traffic; certainly no consideration could be given to place the requested bus stop west of Cheese lane. The question may be to the suitability of siting a stop request in this area since there is no safe means (i.e. foot path or footway) by which bus users could safely access the proposed stop. Following the report there was further support from residents along Cheese lane and Coryates for a bus stop at this location. The PC is now awaiting a response from the officer in charge of bus stops and the highways engineer.

- x. Item 20- Portesham hill centre line works- This works was agreed 18 months ago and still not completed, this is being followed up but is no longer on the list of works by Dorset Council.
- xi. The PC have received a further request for interest in the Glebe houses, this will be kept on file until the next property becomes available.
- xii. The PC is still waiting on the date to install a waste bin at the bottom of Portesham.
- xiii. The Dorset Council ICT services have contacted the PC to help with support at the Chesil internet Cafe

## **2019/05-12 Request to use the Portesham playing field for Park and Ride for the Summer Fete**

The PC considered a request to use the playing field at Elworth for a park and ride facility for the Summer Fete on 29<sup>th</sup> June from 2 to 5pm this was agreed assuming that there is provision in wet weather, and all litter is removed from the site.

## **2019/05-13 To further discuss the listing of the Elm Tree Pub as an ACV**

RD thanked everyone for attending the extraordinary meeting regarding the listing of the Elm Tree Pub as an ACV. The minutes of the meeting having now been ratified is the next step in the process. Following the update the sale of the pub is going through as early as the 11th June. The potential buyers have a chain of pubs. The PC decided to hold the application until the sale was complete or was cancelled. A petition of over 190 residents and visitors in support of keeping the pub would accompany the application as evidence. RD explained that he had spoken to the Dorset Council officer to discuss the decision of the Council and they agreed that this was the right decision at this time. With the emerging Neighbourhood plan in future assets of community value can be listed to protect them for the benefit of the community. The application will be prepped ready for submission after the sale is complete or cancelled.
